Nikki Jones introduced this item to the Committee. The committee reviewed the Use, Site and Architecture plans for the SilverStar Carwash.

The Committee provided the following feedback:

- Present an alternative color option to the red color panel. The committee preferred a burgundy or brown as opposed to the intense red presented.
- Submit a cool toned alternate to the brown brick to complement the cool gray colors.
- Review the capping. The question was asked why there were two different types of cap (smooth and one with an edge.)
- Applicant will need to identify where the RTU's (roof top units) are being placed and provide a line of sight drawing to indicate they are being screened from the right-of-way.
- The rooftop material / back of the parapet wall shall be labeled and the color called out. The committee preferred a light gray material so as to blend into the surrounding area.
- Provide pictures of the other locations.
- Confirm that windows will be true glass (clear glazing).
