APPROVAL OF MINUTES

- September 13, 2021, Meeting Minutes

There was a motion by Alderman Hopkins to approve the minutes of Monday, September 13, 2021, meeting. Motion seconded by Commissioner Olczak. Motion passed unanimously.

Election of Officers

The officers of the Committee shall be elected and serve for a period of one (1) year. All positions were unopposed. Motion by Officer Fus to elect Heather Scrima as Chairman, Cheryl Warczak as Secretary, Tony Fus as Treasurer. Seconded by Commissioner Mitch Lataille and carried unanimously by the committee members.

SAFETY SATURDAY

The Safety Saturday Committee assists in the planning and organization of Safety Saturday. The mission of Safety Saturday is to provide a free and safe event for the community. Safety Saturday is scheduled for May 20, 2022 from 9 AM to 1 PM at the Children's Hospital site.

Officer Fus has met with Children's Hospital to confirm the date. Commissioners were asked to invite safety-type businesses that may be interested in participating. For more information, please contact Officer Tony Fus at fus@nbpolice.org.

The Commission discussed activities and vendors that are being contacted for 2022 such as; the bouncy houses, rock climbing wall, DJ, Cleveland Pub Food, Flight for Life, Sprecher booth, chairs, generators, bike helmet handouts, and demonstrations. There will be a S.W.A.T. Team and Drone demonstration. The NBFD has been contacted and a positive response is expected. The Streets Department will sweep the site before

and after the event and provide signage. Officer Fus will check if they are able to attend the event with their equipment. Alderman Hopkins will work throughout the community to obtain the In-Kind donations.

Volunteers will be needed to; chaperone the bouncy houses, set-up, take-down, traffic control, collect garbage, and assist the D.J. Froedtert Hospital volunteers will hand-out and fit the 500 bike helmets.

In the past Safety Saturday has always been promoted as a "Free" event other than for food. The 2022 will continue to be a "Free Family Event". The event needs to have increased advertising as some of the attendees had no prior knowledge of the event.

Officer Fus has sent out the "Save the Date" notices with the location and time change to vendors. In January, commitment letters will be sent to vendors.

TREASURER'S REPORT

Officer Fus stated the balance of Safety Saturday account is at \$7,000. There have were no expenses paid to date.

Covid has scaled back some community programs. There have not been Public Safety Building tours or squad ride alongs.

The crime statistics have been updated. The majority of calls continue to be for wellness checks, scams & fraud, and property damage.
