REQUESTED ACTION STATEMENT

To: New Berlin Common Council

Date: January 31, 2024

Requested Action:

To amend Section 6-7 of the City Code to remove references to the New Berlin Volunteer Fire Department and the procedure for dealing with vacancies in the office of Fire Chief.

Financial fiscal impact:

None.

Background/Rationale:

Section 6-7 of the City Code currently describes the composition of the Police and Fire Commission, as well as how members of that Commission are appointed and the term of those appointments. The Section as currently written also contains references to the New Berlin Volunteer Fire Department and references presentation of candidates for the position of Fire Chief when that position may become vacant. Since the City no longer has a Volunteer Fire Department and since the process for dealing with vacancies in the Department is dealt with under Wisconsin Statute Sec. 62.13, it is recommended that this Ordinance Section be amended to reflect these necessary changes.

ORDINANCE NO. 2690

**ORDINANCE TO AMEND SECTION 6-7
OF THE CITY OF NEW BERLIN MUNICIPAL CODE
REGARDING THE POLICE & FIRE COMMISSION**

The Common Council of the City of New Berlin do ordain as follows:

SECTION I

Section 6-7 of the Municipal Code of the City of New Berlin is hereby amended to read as follows:

6-7 Police and Fire Commission

The Police and Fire Commission shall consist of five citizens, one of whom shall be appointed annually by the Mayor, subject to confirmation by the City Council, for a term of five years pursuant to §62.13, Wis. Stats. The Commission shall have the powers and duties prescribed by §62.13, Wis. Stats.

SECTION II

All Ordinances or parts of Ordinances contravening the terms and conditions of this Ordinance are hereby to that extent repealed.

SECTION III

The several sections of this Ordinance shall be considered severable. If any section shall be considered by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the other portions of the Ordinance.

SECTION IV

This Ordinance shall take effect upon passage and publication as approved by law, and the City Clerk shall so amend the Code of Ordinances of the City of New Berlin and shall indicate the date and number of this amending ordinance therein.

RATIONALE / BACKGROUND:

The Community Development office has been working on this project and it was first brought up and presented three years ago with no pushback from that council at the time. We would like to revisit this and get a consensus from this council on this project. The goal would be to select an Out of Home Company with the best favorable terms to run and operate and a two-sided Digital Out of Home sign. The profits from this could be directed to debt service for the Arc as this was our initial plan. We will select the provider who can meet the design standards as well as projected revenue terms that best support the city and current market conditions. Most leases are for 15 years. So we would be looking at revenue for 15+ years.
