4. SAFETY SATURDAY

A. Discussion pertaining to the 2024 Event Planning

The Safety Saturday Committee assists in the planning and organization of Safety Saturday. The mission of Safety Saturday is to provide a free and safe event for the community. Safety Saturday is scheduled for May 18, 2024 from 9 AM to 1 PM at the Children's Hospital site.

Officer Fus confirmed the date of the event with Children's Hospital and Froedtert. Commissioners were asked to invite safety-type businesses that may be interested in participating. For more information, please contact Officer Tony Fus at fus@nbpolice.org

The Commission discussed activities and vendors that have been confirmed for 2024 such as; the bouncy houses, rock climbing wall, DJ, Natty Oaks, Sprecher booth, chairs, generators, 520 bike helmet handouts, Murphy & Prachthausser life vest handouts, and demonstrations.

Volunteers will be needed to; chaperon the bouncy houses, set-up, take-down, traffic control, and collect garbage. Employees from Froedtert will assist with hand-out and fit the bike helmets. The DNR will assist with hand-out and fit the life vests.

City Attorney Mark Blum is currently reviewing contracts. Alderman Hopkins will contact Johns Disposal Service regarding delivering a dumpster. Commissioner Kellermann will contact Bucks and Brewers. Officer Fus will contact Waukesha County on the scheduled reconstruction of Moorland Road and the possible impact on the event.

Officer Fus met with representatives from the New Berlin Public Library regarding “Touch the Truck” event that was previously handled by the Recreation Department. The program will be at Safety Saturday this year. Discussion continued regarding the possibility of having the first hour be sensory free as in the past. Since there are no sirens at Safety Saturday, the sensory free hour would not be needed. The possibility of having an ice-cream truck was also discussed.
