Rocklewitz presented the Speed Sentry (All Traffic Solutions) data, which was collected in January 2025. According to the data, 248 vehicles’ speeds were analyzed, and 230 were considered “compliant” (traveling at or below the 25 MPH speed limit), 18 were considered “low risk” (traveling at a speed of 26 MPH – 35 MPH), and zero were considered “medium risk” or “high risk.” Additionally, the data displayed that of the vehicles that were considered “low risk,” nearly all were traveling with the range of 26 MPH – 30 MPH. Rocklewitz advised that based on the data, speed humps did not appear to be warranted.
