## MINUTES

### 1. CALL TO ORDER

The meeting was called to order at 6:01 pm, by Mary English.

### 2. ROLL CALL; DECLARATION OF QUORUM; PUBLIC NOTICE

### 3. APPROVAL OF MINUTES

### 5. NEW BUSINESS

#### A. **25-10:** A resident (via Alderman Horbinski) has requested a sign to monitor vehicles' speeds or stop signs in the area of Crawford Drive and Long Acre Drive.

Dave Rocklewitz presented a summary of the complaint, as it had been forwarded to him via email. Lucas Pichler advised Crawford Drive and Wilbur Drive were both main roadways through the residential area and both roadways had a history of speeding related complaints. Pichler advised even if speeding was the concern, stop signs should not be used to control drivers' speeds. Pichler additionally advised based on the number of

residences on Long Acre Drive, the traffic volume coming from and going to that roadway averaged 86 trips per day, which would almost definitely not produce enough volume to fall within the guidelines needed to warrant stop signs at the intersection. Pichler further advised other measures used to potentially warrant a stop sign would be crash history at the intersection. Pichler advised he did not suspect there would be enough crashes at the intersection to warrant a stop sign; however, he also did not have immediate access to crash information to confirm that belief. Mitchell Lataille advised he believed it would be prudent to gather and examine the crash history and then make a decision on how to proceed with the request.

## 6. TABLED ITEMS

- A. 24-16:** Multiple residents have requested consideration for the installation of stop signs or yield signs at the intersection of Pleasant Hill Drive and Greenhill Road, due to the dangerousness of the intersection. **(Tabled for traffic study in Spring 2025)**

Motion Passed 8-0

Lucas Pichler presented the traffic study data results, which was collected between 06/09/25 – 06/16/25. According to the data collected, the average vehicles per day on the minor approach (Pleasant Hill Drive) was 230 vehicles per day. Pichler advised using the data, the City of New Berlin Two-Way Stop/Yield Guidelines showed stop signs and yield signs were clearly not warranted for control at the intersection of Pleasant Hill Drive and Green Hill Road. Pichler also presented a crash report from 2022, while also noting that the Two-Way Stop/Yield Guidelines only required analysis of crash history from the previous 12 months. Pichler advised even with extending the crash history back to 2022, the Two-Way Stop/Yield Guidelines again showed stop signs and yield signs were not warranted for control at the intersection.

Lucas Pichler presented the traffic study data results, which was collected between 06/16/25 – 06/23/25. According to the data collected, the average vehicles per day on the minor approach (Gatewood Drive) was 73 vehicles per day. Pichler advised using the data, the City of New Berlin Two-Way Stop/Yield Guidelines showed stop signs and yield signs were clearly not warranted for control at the intersection of ranch Road and Gatewood Drive. Pichler also noted there was no crash history at the intersection; therefore, the Two-Way Stop/Yield Guidelines again showed stop signs and yield signs were not warranted for control at the intersection.
