Notice of Closed Session: The Board of Appeals may adjourn into closed session from time to time during the meeting, pursuant to Wisconsin Statutes § 19.85(1)(g), for the purpose of conferring with legal counsel regarding litigation or legal strategy concerning its determinations on motions made or other issues arising during the meeting, and/or pursuant to Wisconsin Statutes § 19.85(1)(a) to deliberate concerning a case which was the subject of any judicial or quasi-judicial trial or hearing before the Board of Appeals.

relevant to whether the City of New Berlin Plan Commission erred on December 8, 2025, in finding the use of the subject property by Milwaukee Rescue Mission – New Journey as proposed is a permitted use per applicable laws.

- 7. Presentation by Other Parties, Including Plan Commission and Property Owner**
 - A. Presentation of testimony, witnesses, and submission of evidence by other parties to the appeal, including the Plan Commission and/or property owner, in accordance with established procedures and relevant to the issue of whether the City of New Berlin Plan Commission erred on December 8, 2025, in finding the use of the subject property by Milwaukee Rescue Mission – New Journey as proposed is a permitted use per applicable laws.
- 8. Appellant Rebuttal**
 - A. The Board of Appeals may allow the Appellants to offer brief non-repetitive rebuttal testimony, strictly limited to issues raised by the testimony provided by other parties.
- 9. Surrebuttal by Opposition**
 - A. The Board of Appeals may allow the Plan Commission and/or property owner to offer brief non-repetitive surrebuttal testimony, strictly limited to issues presented by Appellant's rebuttal.
- 10. Appellant Legal Argument**
 - A. Legal counsel for the Appellant will be given an opportunity to provide legal argument and/or summation on the issue of whether the City of New Berlin Plan Commission erred on December 8, 2025, in finding the use of the subject property by Milwaukee Rescue Mission – New Journey as proposed is a permitted use per applicable laws.
- 11. Plan Commission Legal Argument**
 - A. Legal counsel for the Plan Commission will be given an opportunity to provide legal argument and/or summation on the issue of whether the City of New Berlin Plan Commission erred on December 8, 2025, in finding the use of the subject property by Milwaukee Rescue Mission – New Journey as proposed is a permitted use per applicable laws.
- 12. Property Owner Legal Argument**
 - A. Legal counsel for the Property Owner will be given an opportunity to provide legal argument and/or summation on the issue of whether the City of New Berlin Plan Commission erred on December 8, 2025, in finding the use of the subject property by Milwaukee Rescue Mission – New Journey as proposed is a permitted use per applicable laws.
